RE: Caldwell County Appraisal District Delinquent Tax Collection Report – Fourth Quarter 2017 – 2018 (April - June)

Dear Board of Directors:

Attached, please find our quarterly report regarding our delinquent tax collection efforts on behalf of the Caldwell County taxing jurisdictions for which we represent. During this quarter we collected a total of \$388,001.15 in delinquent taxes, penalties and interest.

Delinquent Tax Collection Report

Here is a summary of the specific delinquent tax collection steps we have undertaken during the Fourth quarter of the 2017 - 2018 tax year and the results of those actions.

New Lawsuits – We filed 27 new lawsuits involving 38 properties. These suits sought the enforcement of \$155,349 in delinquent taxes, penalties and interest.

Suit Dismissal – During this quarter we prepared and submitted notices of non-suits in 13 suits involving 29 property accounts and \$179,398 in delinquent taxes, penalties and interest. A non-suit is filed once all taxes in a given suit have been paid.

Judgments – During this quarter we obtained 12 judgments involving 19 different properties. These judgments sought the enforcement of \$111,493 in delinquent taxes, penalty and interest.

Tax Sales – During this reporting period we held one regular tax sale which included 9 cases involving 16 property accounts. As a direct result of this sale, there was a total revenue collected of \$20,588 in delinquent taxes, penalties and fees.

Mass Mailing – During the fourth quarter of the collection year we mailed an individualized demand letter to every delinquent taxpayer reminding them of their obligation to the various taxing jurisdictions and encouraging them to submit payment of their delinquent taxes.

Re: Press Release / Tax Foreclosure Sale

On Monday, July 9, a tax foreclosure sale was levied and issued for publication. The sale, organized by the law firm hired to collect delinquent property taxes, is scheduled as a last resort. According to the Linebarger Goggan Blair & Sampson, LLP Firm the sales only occur after property owners fail or refuse any other payment options. Sam Turner, an attorney with the Austin based Linebarger Firm, remarked "We really don't want to sell anyone's property but the reality is that if you own property in Texas you are obligated to pay local property taxes. If you fail to pay those taxes your property can be sold."

The tax sale that was levied upon on July 9 will be held on Tuesday, August 7 at 10:00 AM and includes twelve (12) properties that are scheduled to be auctioned off; the property owners are able to come in and make payment thereby preventing their property from being sold if done prior to the scheduled sale date. Turner also explained, "The longer you wait to pay the more it will cost you. Between penalties, interest, court costs, publication fees - the cost of paying immediately before a sale can often be twice as much as it would have been had the tax been paid on time."

Turner went on to state that their law firm has begun the process of preparing a list of delinquent taxpayers for purposes of publishing in the newspaper. The list will be randomly generated from all delinquent tax accounts across the County. The list will be compiled from public information and will include the name of the assessed party and the total base tax amount owed on their property. Once compiled, the list will be submitted to local news organizations so that it may be published. As Mr. Turner explained, "Like it or not, as property owners it is our obligation to support our local government and schools by paying our share of the tax burden. If you fail or refuse to do that then the Texas Property Tax Code provides legal consequences. Our law firm will use all of those legal tools to insure that each property owner pays their fair share."

Taxpayers that believe that their name might appear on this list should take immediate action to ensure that it is not published by contacting the Caldwell County Appraisal District in order to take care of the tax obligation. In the Luling area, payments can be made at the Caldwell County Annex Building located at 505 East Fannin, Luling 78648.


