Dear Mr. Munoz:

Attached, please find our quarterly report regarding our delinquent tax collection efforts on behalf of the Caldwell County taxing jurisdictions for which we represent. During this quarter, we collected a total of \$586,621 in delinquent taxes, penalty and interest.

Delinquent Tax Collection Report

Here is a summary of the specific delinquent tax collection steps we have undertaken during the second quarter of the 2021-2022 tax year and the results of those actions.

New Lawsuits – During this quarter, we filed 8 new lawsuits involving 15 properties. These suits sought the enforcement of \$188,911 in delinquent taxes, penalty and interest.

Suit Dismissal – During this quarter, we prepared and submitted notices of non-suit in 10 suits involving 10 property accounts and \$112,649 in delinquent taxes, penalty and interest. A non-suit is filed once all taxes in a given suit have been paid.

Judgments – During this quarter, we obtained 4 judgments involving 4 properties. These judgments sought the enforcement of \$33,489 in delinquent taxes, penalty and interest.

Tax Sales – During this quarter, we held one regular tax sale which included **2 cases** and involved **8 property** accounts. As a direct result of this sale, there was a total revenue collected of **\$1,348** in delinquent taxes, penalties and fees.

Excess Proceeds – During this quarter, there were no excess proceeds to disburse.

Mass Mailing – During the second quarter of the collection year we conducted 2 mailings, of which, we mailed an individual demand letter to every taxpayer reminding them of their obligation to the various taxing jurisdictions and encouraging them to submit payment of their delinquent taxes.

Tax Warrants - During this quarter, we did not file any tax warrants.

Interventions – During this quarter we filed 4 new interventions involving 14 properties. These interventions sought the enforcement of \$23,174 in delinquent taxes, penalties and interest.

BE IT FURTHER RESOLVED, that the taxpayer liaison officer shall not influence the process for selecting appraisal review board members.
